**IMPORTANT NOTE:** As a Bethel Native Corporation (BNC) shareholder, you are strongly encouraged to execute a BNC Stock Will to ensure that our BNC stock will be distributed in the desired manner. It is important to update your BNC Stock Will upon the death of a designated beneficiary, after giving or receiving a gift of stock or if additional shares are inherited. Marriage, divorce, the birth or adoption of children and other life changes are also reasons to complete a new stock will.
